This one day conference will cover a broad range of issues related to violence and mental health. Topics include psychopathy and antisocial behavior in youth, sexual aggression, bullying and violence in schools, medication treatment of aggression, violence and psychosis, and individual and community factors that increase risk for violence. There will also be a panel discussion including speakers, and with audience participation.

Conference Goal

This conference will provide mental health practitioners, correctional staff, teachers, law enforcement personnel, and other professionals whose work involves working with, or developing policies related to, violent individuals with state-of-the-art perspectives about the causes and treatments of various high-profile types of violent behavior.

Target Audience

This educational activity will be of interest to clinicians (psychiatrists, social workers, nurses, psychologists, certified counselors and other mental health providers) and researchers working with people whose behavior is characterized by violence towards others; to teachers and other school-based personnel who encounter violent behavior among students, to those in the correctional and criminal justice systems, and to those interested in public policy related to violence reduction.

Faculty

Douglas Boyle, JD, PhD, Violence Institute of New Jersey - Rutgers University Behavioral Health Care. Dr. Boyle is a senior researcher at the Violence Institute of New Jersey, who has many publications in the area of violence and criminology, including community level factors related to violence.

Dorothy Espelage, PhD, University of Illinois-Urbana-Champaign. Dr. Espelage is a nationally recognized researcher and thought-leader in the areas of bullying, violence against teachers, and violence targeted towards LGBTQ individuals.

Kent A. Kiehl, PhD, University of New Mexico and nonprofit Mind Research Network. Dr. Kiehl is a leading investigator in the neuroscience of psychopathy. His laboratory has amassed the world's largest brain imaging database of forensic populations (over 3000 inmates to date). He has published over 125 papers and his work has been featured on NPR, Scientific American, and in The New Yorker.

Raymond Knight, PhD, Brandeis University. Dr. Knight has done pioneering research on the characterization, and treatment response prediction, of sex offenders, and has developed one of the most widely used measures for assessment of this population, the MIDSA, which is widely used to guide treatment in correctional treatment settings.

Jeffrey Mattes, MD, Rutgers University Correctional Health Care, and the Psychopharmacology Research Association of Princeton. Dr. Mattes is a psychiatrist who has conducted many studies evaluating medications for the treatment of impulsive aggression, and has written influential papers on this topic.

Steven M. Silverstein, PhD, Dr. Silverstein is an expert in behavioral interventions for people with serious mental illness, including psychological interventions to reduce aggression, and to promote improved cognitive functioning and social adaptation. Dr. Silverstein is the Director, Division of Schizophrenia Research, and Executive Director, Violence Institute of New Jersey, Rutgers -University Behavioral Health Care; and Professor of Psychiatry, Rutgers -Robert Wood Johnson Medical School, Rutgers Biomedical and Health Sciences Piscataway, NJ
